Mission Statement

The DDS Foundation promotes the adoption, interoperability, and success of DDS standards to a wider user community

- Creates and expands an ecosystem of DDS users
- Promotes and helps evaluate DDS standards
- Defines industry-specific data models
- Supports industry-specific adaptations and implementations of DDS
- Ensures positioning, awareness, and interoperability between DDS vendors and products
- Builds a library of use cases, data models, application software, and system architectures
